Donation	Thank you to THE Coalition for the donation of \$659.75, half of the proceeds from Midland Days. This donation will be added to the Chamber's Building Savings account.
Gold Book Ad.	Lisa presented a rough revision of our 2-page ad in the Ute Pass Gold Book. Since the Gold Book audience is local, Lisa will add a suggestion for folks to "keep \$ local" by encouraging them to check out the many local businesses on the Chamber's new website.
Divide sign	More discussion on the "Welcome to Divide" sign: Geet suggested that the Chamber look into Federal grants that provide money for Highway info and

The Depot	David Martinek is hopeful that the sewer variance will be approved at the hearing on Thurs. April 22. We should be able to occupy the east wing by June or July. Anyone willing to donate furnishings?
DCBO	The first meeting of the Divide Community Betterment Organization was held last month. Several items are being prepared for the organization's attorney: Articles of Incorporation (to be kept broad for flexibility), liability, and ownership of the Depot.
Lion's Club	Monty Whitney is reviving the Ute Pass Lion's Club. This organization focuses on providing vision services. David Martinek will represent the Chamber at their 1 st meeting on 4/19 at 6:30 pm at the Ute Pass Cultural Center.
Kite Flight	Lee Taylor made a motion to change the date of the Kite Flight from the first Saturday of summer break to the first Saturday after school starts in Aug. David Martinek seconded the motion. We can still advertise with flyers at local schools, but may have better weather. For 2010, the date will be Sat. Aug. 28 from 9am – 1pm. Lisa mentioned that Mike of BTR Interiors asked if we would like to participate in a Garage Sale with him. Would we like to do it in conjunction with the Kite Flight? Pete Kuyper would let us use the open field on Hwy 24 just North of the Post Office. More discussion to follow.
New Industry	Lee announced a new industry coming to Teller County. GE is sponsoring a test conversion of a power plant in the Springs. The plant will begin using wood chips from our area for fuel. Trees thinned from forests in our area will then be converted into chips and transported to the GE plant in the Springs. This operation may provide many new jobs in our area: logging, chipping, and transportation. Another obvious result: reduced fire danger and healthier forests.
